Most Rev. Archbishop:

We have been informed, that an appointment of a Catholic General Agent for the Cath. Missions among the Indians will take place - & that the Bishops are expected to designate the proper persona for such Office; we thank God - that this great wrong on the part of the U. S. Government to the poor Catholic Indians is being done away with. As Your Grace is in a better position to judge, who ought to be recommended for said office - & to insure unity of action, as far as we are concerned & to express Our Confidence in you - we beg Your Lordship to ask also in our name and stated and we hereby give you the necessary authorization for this purpose.

Dear Sir:

Enclosed please find a
Report about Catho. Indians - who have
been under Cath. Priests influence till they
were removed to the Indian Territory and who
have a Protest Agent, to the best of my
knowledge. - All our Indians are moving
and have been moved on their Reservations
in the Territory if we have none, that have
Agent over them - the Territory belongs
under the Jurisdiction of the Bishop of
Little Rock - but as our priests tend
to move Indians occasionally - I do not
deem it important to give you what
I have informed you I presume.

One of the Fathers was on his journey, when
a short time ago I went to see him as
he will not return before a couple of
weeks, I was informed. This is only
the report of one of the Fathers of the
Society of Jesus - and complying
with your request to send it as soon
as possible I thought it imprudent
to await his return. Hopely you
will be able to get a Cath. Agency
for the Orages at least I pray
that our blessed Lord may bless your
endeavours I am

Dear Sir:

Enclosed please find a report about Catholic Indians - who have been under Cath. priests' influence till they were removed to the Indian Territory and who have a Protest Agent, to the best of my knowledge. - All our Indians are moving and have been moved on their Reservations in the Territory & we have none, that have an Agent over them - ; the Territory belongs under the Jurisdiction of the Bishop of Little Rock - but as our priests tend to these missions occasionally I do not deem it impertinent to give you what little information I procured. One of the Fathers was on Missions, when a short time ago I went to see him & he will not return before a couple of weeks, I was informed, this is only the report of one of the Fathers of the Society of Jesus- and complying with your request to send it as soon as possible I thought it imprudent to await his return. Hoping you will be able to get a Cath. Agency for the Omages at least & praying that our blessed Lord may bless your endeavours, I am
