Rt reverend and dear Monsignor:

I said I would inform you of the Cibecue school question as soon as negotiations started. This morning I went to see Mr Donner about having the government turn over their school and residence to me. He said he would write at once to the office. My arguments for the transfer were the following:

a) There was no need of three schools in this one village. The Lutherans have one, at present the government has one, and now I am determined to have one.

b) When I start my school the government school will have a little more than two thirds of the pupils left, with prospect (and a good one) of losing more as time goes on. Finally they will have to close up and leave their buildings stand idle.

c) If they turn the school over to me they save themselves the expense of maintaining a school and save me the expense of building one. We are both ahead and they know as well as I do that we will give the pupils as good and even a better education than they are getting now.

d) The office has done that for the Lutherans at East Fork (near Fort Apache) so there is a precedent. Now is our turn.

e) The children would then be turned over to the Lutheran and Catholic missions, the two churches to either of which they must all belong

f) If the government wants the different denominations to do their work effectively they should let them care for the education of the children where there is no need of government schools and where the denominations can and will give as good and even better education than they are getting.

g) My plan is to get a sufficient endowment to run the school on its interest. This would make it a secure and permanent undertaking.

h) I have first hand information to the effect that the government can get all the money it wants to care for the Indian affairs, and that they are glad to divert the money in these channels for financial reasons, or for the welfare of the country at large, for the same reason that they appropriate monies for a battleship. If this is the case (I never had that impression) it would be an easy and sensible thing for the office to give the missionaries a lift such as I would need in this case to put the school on a good footing, instead of making them hunt all over creation for support. Of course some norm of distribution would have to be established to avoid the squabbles among the denominations e.g. a certain flat rate regardless of denomination or adherents. The denominations would have to do the rest themselves just as before. I am making these remarks not that I expect this to happen at once, but as pertaining to something we might find sentiment for and later on a working basis. Provided THESE REMARKS I HEARD FROM ONE WHO KNOWS ARE TRUE.

I hope you will do all in your power monsignor to push this through. I see no reason why it should not find the office favorable. With best wishes I am Your pal

P.S. Monsignor, what can you do in the line of salaries for teachers? I am just trying to get the government school at Cibecue (inter nos). I think this probable for they have done that once before. The whole, if the transaction is successful, will be turned over to us for our use. In this case, they know I am determined to build if they do not come across, and they might as well quit when I get started. There are 40 in the school now and when I take out about half at the start, they will not have many more to keep them going, especially the following year after the Indians begin to drift this way. The government is as a rule satisfied to get rid of this expense. I will let you know when things get under way, so that you can push it on that end.

After the Mass Christmas morn I had them all pray for you and Reverend Father Mulvihill for this great gift. I will adorn the chapel every Christmas hereafter. Permit me to thank you from the bottom of my heart, in my own name and that of the dear children for this beautiful gift. I do hope that the Christ Child has given you and dear Father a most happy Christmas. May I also wish you and Reverend Father a most prosperous New Year though I may be late in my wishes. They are nevertheless sincere and hearty.

Dear Father Fidelis:

I have your letter of January 1. I will answer your questions in the order presented:

(a) Three schools may not be needed at Gibeon but the Government will not close its school doors because some denomination proposes to open a new school in the same locality. If this were a fact the Government would have to close schools in many places.

(b) Until such time that the Government sees fit to close a school there is no possibility of having it turned over to Catholics or anybody else. Whenever a school is closed the abandoned buildings might possibly be leased for educational purposes at a nominal cost.

(c) The Government certainly will not turn any school over to Catholics or Protestants in order to save expenses for any party. It is true the parties concerned might be benefited by such a transaction, but the Government does not argue that way. You maintain that in the Catholic school the children will get a better education, but you never read or heard of a Government institution admitting that fact.

(d) What the Government did for the Lutherans at East Fork, was done at a time, no doubt, when such a transaction would not be questioned. The Lutherans probably were the only ones on the ground at that time. To do such a thing now would evoke a storm of opposition not only from ourselves, were others thus benefited, but also from any other sectarian institution were the Catholics benefited.

(e) Granting that the Catholics and Lutherans are in the majority still there is and always will be a certain class of Indians who would object to sending their children to either a Catholic or Protestant school.

(f) What you say would be an ideal situation. But where a Government school has been in operation for a number of years, be assured that it is not going to close up and move off because you or somebody else proposes to put up another school. Question (f) was partly answered under (b). "It is a fair field with no favor and the devil takes the hindmost."

(g) Try and get an endowment! If you would get one I should say that then your troubles would begin. Experience has shown that a lot

of grief and pledges and tie-ups and red tape are appended to a foundation. It is like being presented with a thorough-bred dog with a tin can tied to its tail. You will be doing well if you get enough money for running expenses.

(h) The Interior Department may be able to get ample funds (it really cannot) to run the Indian Department but these funds are positively prohibited by law to be diverted to sectarian purposes. The Catholic contract schools we have and Government monies appropriated for them are not taken from Government funds. It is Indian money. The Government simply acts as the custodian for the Indians with whom it has treaty rights. The Government gives the Indian the right to determine what school his children shall be educated in. The Indians at Whiteriver can choose their school, etc. The Indian Office has not and can not divert any money to any channel than that directed by law. Your "first hand information and from one who knows" is pure bunk. The Government will scarcely allow any additional contract schools.

In your letter of January 2 you ask about teachers' salaries. I have no funds for such purposes. In fact I am about bankrupt. All I can do is to insert your need in THE INDIAN SENTINEL. In that way some reader may be willing to furnish salary for a teacher.

Dear Mrs. McGlannan:

Your parcel is at hand. Several of the articles enclosed will be of great utility to me in my travels up here in the mountains, especially the trunk and the coat. The other articles I can use in the missions. I want to thank you from the bottom of my heart for this fine shipment and also for the zeal you are manifesting for the home missions. I shall get the little Apache kiddies to pray for you. I, too, shall include you in my prayers.

In your letter you said you would like to hear something about the mission. I am at a loss what side of the cloud to show you, the silver or the dark side. But I guess we see and hear enough of the dark side of mission work so I am going to give you the bright side and talk about the country and the people. This reservation is in the Whitemountains. We are a mile high in a huge forest belt of pines and cedars. Authorities say it is the largest in the country. There are many mountain streams which abound in trout. The country is live with wild turkeys, deer, bears, mountain lions and other game usually found in such belts. This does not sound like Arizona at all does it? This is only one section of it. Although it is mountainous throughout, it has parts that are called the desert and they are hot too. Down there we find the copper mines. North of us (also desert) we find the petrified forest and the painted desert. The grand canyon is in a better belt. Arizona in my opinion is the most wonderful state in the Union. You can find almost any altitude and climate, from blistering hot to icy cold. There are ice caves in the desert and hot caves in the cold districts. Lots of contraries and lots of vegetation, i.e. varied. The desert had the cactus, the mountains the trees and many varieties in both. Coming back home I want to say a little about the Indians. You have read enough about the Apache to know their traits. Well we are just pioneering among them and trying to get them somewhere. They are still primitive in their ways. I am glad to say however that they are now gradually leaving their cold and dark tents and building houses for themselves. An Apache is anything but clean but we hope to take off a few layers of dirt before long. The evolution is slow and in spite of themselves, *but it will be sure, I am confident.*

Rt reverend and dear Monsignor:

I am in receipt of your letter about the school proposition. It appears as if there was not much of a chance for getting this Cibecue school. Still I was willing to try even, if I should fail. I just wanted to give you some pointers that affect this case, so that if Burke should call on you, you would be informed. The fact is monsignor, that both the Navajo school at Fort Apache and this reservation are pulling hard for money and cannot get it. Both superintendents told me that and it is evident that their statements are true. I just wanted to take honorable advantage of the situation especially since I had a precedent and things here were favorable. If I could save myself the cost of a school (at least \$5000) I was going to do it. As I intimated in my letter that 'statement from one who knows' is true secundum quid but not de facto as facts prove. At least around here, some of the recent denunciations of the government Bureau have some foundation in truth.

I mentioned that I wanted to get an endowment for the school. You bet your sweet life I would not take one with the usual red tape and obligations (unless they were very easy to fulfill and reasonable). But my idea of an endowment was to raise a good lump of money by stringless donations and other money raising schemes. The scheme is launched already and though entirely new, it might work out. If it does, and that only half as good as it might, I shall easily have enough to put up the school and completely furnish it. I am just waiting results. If the idea makes an appeal, I am going to carry it out on a larger scale at once. But I figured that if I could set the school at Cibecue I could put that much in the so called endowment fund and make it bring interest. An endowment of about \$50 000 will make me safe for a while, provided I get a salary for the teachers. It is a goal devoutly to be wished and to be worked for. My superiors on the coast think a school is at present impossible (financially). But I wish you would put in an appeal for a teacher anyhow. I can use it if the school becomes a reality anyhow, or it can be used in another school. There is nothing lost in getting the money.

I am enclosing a letter Very Rev James J. Horsburgh. I keep an eye open for furnishings at barbecue. I am so bloom busy that I even have no time to crack a joke. Casually I might say that the article of P "Augustine "The flying padre" in the Sentinel came to my notice in Phoenix, just when he was there. The tilt was amusing. The fact is that down in the desert the aviators stay out of the sky all day during the summer on account of the air pockets and twisters. Passenger lines follow the mountains as much as possible. A regular passenger line is coming through Holbrook, Winslow, Flagstaff Williams Prescott. These are almost the highest places in the state. All they have is mountains. Fellows who fly to Whiteriver told me there is no hazard at all. They would prefer to fly here than in the desert, at least during the summer. So all in all we are at the least on a level and it is just as hard to settle this as it is to distinguish between one who is a "nut" and one "sanely enthusiastic". It sure takes a philosopher to distinguish between them.

Very reverend and dear Father:

Monsignor Hughes has just informed me that you, as director of the Propagation of the Faith Society, have made a donation to him and that a part of it will be given to me. I wish to thank you sincerely for this. It means so much up here. You can rest assured that it has come to the right place. If the Faith is to be propagated with this money up here, it is absolutely going to do it. The reason is this:

We have just opened this mission among the Apaches about six years ago. The field is entirely new. It is attended by one Father in comparison with the six preachers of the lutheran sect. We have no schools, with four to their credit. One catechist to their six, not mentioning the members of their families. They, themselves, admit that only the Catholic Church can do anything with the Apache. Their orphanage and boarding schools are large institutions, have large attendances, but there are no ostensible results. In fact they claim they are not here to civilize the Indian. This is indeed a sad picture and it shows too what we must do among the 2,500 Apaches of this reservation. As Indians, they are 25 years behind any other tribe. Government officials say that themselves. As Christians they can not be reckoned at all. They are heathens, pure and simple. They have qualities that will make them us good and even better Catholics than many other tribes. mescalero in New Mexico proves it. So far we have been limping along without moving. There is sure a lot of faith to be propagated here and let me tell you frankly, it looks like it will be a long time till it is propagated. We might be visible but they do not feel our presence. From this pen-picture you can readily realize what your donation means to this reservation and hence also to Monsignor Hughes who is trying his utmost to help. Of course I realize he can not give any more than he has and that is not much, granted too that the money of the society is getting to the proper parties, it seems that it will be a long time till he does get enough, unless the propagation on whom we depend to a great extent has an unexpected era of prosperity. Till then the Indians and the missionaries who are struggling along as best they can will have to wait. but that is just what is getting me and many others. The field is ripe but there is none to gather the harvest. In the meantime, others are sowing cockle.

It would be useless to make any advances to the Interior Department about the Cibecue school building until after March 4. Should you at any time know of a Government school closed or to be closed I would suggest that you inform this office and transact the Government business through this Bureau. I will tell you confidentially, the nominal lease charge for abandoned Government school property is usually \$5 a month.

In my opinion endowment at the present time is impossible. Fifty years from now it may be done. In the meantime all we can do is to get all the funds possible and use them for the upkeep of the missions. Should you get the school I shall put an appeal for the teacher's salary in THE INDIAN SENTINEL.

Be sure that I wish you success in your zealous efforts.

Dear Monsignor, I received your several letters but have not had
occasion to answer them till now. (separate envelope) R.M.C.
I am enclosing letters of thanks to Mrs P E Joyce, Sophia Petz and the children of the Ursuline Academy at New Orleans whose gifts are now at hand. Among the latter donation by the children of the Ursuline Academy, I wish to remark that it is the result of a special appeal I made in person to them and others for the school I intend to build. It is intended for a school and not for my salary. Of course I am not going to fight about a miserly five dollars. You can use your own judgement on that. But if any more should come in your way that would be of value for this enterprise, I wish you would assign it to that cause. How can I build a school if all I receive goes to my salary?

Mr Donner informed me that the government wants to keep their school out at Picayune. I shall try to build my own.

This morning I wrote to Jesse Smith at Glendale asking him to have the title for that car placed in my name. He first sent me that title about two months after the purchase, since he did not have my address. I happened to write to him about credit on a defective part and that is how he got in touch with me and sent the title. I am sure I sent the title to you in my last letter. Perhaps it was misplaced. It does not matter, however, I think things will be straightened out alright.

I know I am a telegram boy but the immediate settlement of the truck proposition happened to mean a saving of \$80 to me. I did not want to go ahead and trade till I got your opinion. My superiors on the coast balked at the proposition in spite of the fact that it would net me a saving of \$1000 in freight right now. Last year I spent \$97.65 on truck freighting. Often I drove behind the truck, carrying the load, in my sedan in grand fashion. I had the pleasure of footing the bill later. I must make these trips anyhow and a Ford truck is any day as good looking as a model T sedan and it rides every bit as comfortably as a Dodge touring. However, I have managed to save the money anyhow since I have gotten the free use of a two ton Nash truck for freighting the building materials. The way it looks now I shall get the three thousand I need for the school, provided, of course, that the "Arquette League gives me a little lift. I must then get the money for furnishings. I am trying my best to get that school. I need something to carry on the work. One man cannot do justice to this reservation. There are no prospects of getting another father for several years.

Say what the civil are you trying to do? Make money on me? I wired for those statues of the sacred heart, blessed Virgin and St Joe and you sent them. I never did say that I would reimburse the Bureau. Look at the enclosed letters from Monsignor Hughes. Looks like we are getting back to Butts again.

Did you forget about that mimeograph? Send her as soon as
you can.

Ceterum ambulemus in pace et mutua caritate. A happy
Easter to you monsignor and to Maude and the rest of the crew
over there. We are still in the octave so I guess the greetings
will still count. I am so bloomin busy right now that I just have
enough time to take my regular breath. Could not get my wishes to
you in time for Easter, but I did remember you all on that
glorious day. We prayed for all with Jewish blood and for all
gentiles. I heard quite a few people in Washington are eating
onions. A bad sign Monsignor. I could have smelled that in your
letters. The next time you write sign your self 'Shylock'. Drop
in on your way to the coast and smell some pork at Whiteriver.
The government is fattening up two little fellaws for me in their
pens.

I have not as yet caught on to all the workings of the thing while looking at it tonight but I shall get it after a little inspection. It will be a great lift in the school work up here especially since I am going to build that day school out at Cibecue. While talking of day schools I want to take up another matter I have on my heart. Some time ago a man in St. Louis by the name of Schimmel died and in his will bequeathed several thousand dollars to the Indian missions through the Bureau. I at once wrote to Mr. Schneiderhahn, a lawyer and the executor of the will for a share in the will. (This was previous to his letter to me telling me that it was willed through the Bureau). As soon as I got the letter of Mr. Schneiderhahn who is a personal friend of my father, and through whom whose efforts this money was bequeathed to the missions, I decided that I would write you at first opportunity for a lift in building the day school. My superior was just here this week and he insists on the Bureau living up to its promise to build this place up. I happen to know all the ins and outs of the whole affair and I think that when the Bureau has a chance as it has now to fulfill its promise it should do so. A good lift now would help to iron out a lot of difficulty and put the Bureau in better grace. The position I am in is as follows: My superiors refuse help because they fall back on the promise of the Bureau and the Bureau tells me it has nothing. Well that is not going to get me nor the mission anywhere. I am just between the devil and deep blue sea. Here you have a chance do your part and I hope you will. A thousand will be a good lift. Let me know your decision in this matter.

Right reverend and dear Monsignor:
Probably Mr. Donner the agent here at Whiteriver has already reported the incident that occurred here this week as I took children to St. John's Mission school near Phoenix. I knew that my side of the story would be wanted and I give it herewith.

Mong the boys to go along was Marcus Gatewood. He is of the Lutheran denomination. His stepfather John Williams (guardian) approached me just as I was leaving Gibeon with the rest of the children and told me to take Marcus along as the boy had told him he also wanted to go to St. John's. I asked the stepfather to come in with me and sign up but he said he could not do it at present since he had lost so much time the previous week. He said in the presence of all the children and some grown Indians that he would sign later. I then went to Mr. Donner on arriving at Whiteriver with the children and told him of John Williams' request. I also told him of the need of signing later. Mr. Donner said that would be alright. He also said that Marcus could go as far as he was concerned but that he would want to hear what Mr. Mackey the principal had to say about it. I saw Mr. Mackey a few minutes later at the post office. He was unwilling to let the boy go because as he said he did not want to reduce the number in the class(seventh) which was about 22 or 23. I told him then that one more or less would not matter. I also told him that the government recognizes the right of the folks to send their children to any mission school provided it is not during the school year that the transfer is made. He persisted in refusing saying too that since they had brought the boy so far they did not like to change him. He said he would see Mr. Donner. I told him to let me know what was to be done. In the meantime according to a prearranged plan (*with Mr. Donner*) I took some of the other children who had not been examined physically, to Dr. Ferguson at Fort Apache. I took Marcus with me so that in case Mackey should agree there would be no delay. I told Marcus to tell Mr. Mackey his intent and to let me know in the morning. When he came in the morning he said that Mackey had refused. I then told the boy that if he was still anxious to go I would take him along nevertheless since it was clear he as well as the stepfather wanted it (*spontaneously* as far as I know) and that Donner made no difficulty about signing later. I knew that as long as the rights of the parent were secured and their consent apparent I could take the boy and notify the agent later in case he should not find out about it. The law simply requires that the agent be notified. Moreover I would not have a last minute dispute over what I considered of little import. The law has been clearly stated several times to the effect that: The parents have full right to send their children to a mission school and that if the agent refuses we should insist on it anyhow. Now Mr. Donner is not against it except that Mr. Mackey opposed it. But Mr. Mackey evidently has a poor excuse for not letting the boy go. They have sent out children of the higher grades right along. Why should this

case be excepted. Because ther were only 22 or 23 in the class.⁴
that seems foolish. It also seems arbitrary to limit an otherwise
clearly stated law in this fashion. I simply took the law to
mean what it said and only that. If we allow a hundred and one
"ifs and buts" we do not know where we are. The law is as good as
nil. Moreover if we have to wait for word from the principal or the
agent (I mean consent) where it is denied the agent or principal
determines the fate of the child and not the parent or guardian.
In that case the law is entirely nullified. For the above reasons I
simply took the child along. A telegram was sent to Phoenix to
Pedro Martinez in which Bonner said that if he would not bring
Marcus back he would be deprived of any and all privileges. I did
not give the telegram to Pedro because it would spoil his stay
and because as far as I knew he had nothing to do with the case. I
had decided to let the boy there and I was holding myself responsible
for the move. I do not know why Bonner did this. He is either under
the impression that Pedro is responsible for the boy going or he
wanted to force me to return the boy by threatening to punish Pedro.
If the first was his mental attitude I think he is wrong for I
never heard that Pedro had anything to do with the boy or the
stepfather. I am not conscious of anything of that sort happening.
Even if it did happen what does it matter? Pedro is not a real
government employe. He is doing fence work up on his ranch for
the government but he is for this reason no more a government
employe than an Indian who mixes cement for a few days while the
government is building. If Bonner tried to force the issue by
threatening Pedro it was not fair. I hardly think that he would
have done that.

From all this you can see that I did the above for the
simple reason that it was the only alternative. I read and reread
the law. It was clear enough to me. There were no exceptions made
except regarding a transfer during a school year. The exception
on the part of Mr Mackey seemed trifling anyhow. I knew Mr.
Bonner would support Mr Mackey although Bonner himself was willing
to leave the boy go. I did not want to quarrel the last minute
and at the same time I knew that the law only requires that the
agent be notified of the transfer. I intended to do that later
if necessary and took the boy along. If the law permitted the boy
to go he was going as far as I was concerned. I had no intention
of walking over any authority but I did want to avoid a pitched
battle. In fact I am not conscious of overriding any authority.
If the law is such we obey it just so.

I wish you would let me know what is to be done in the
case. I shall get the subsequent signature of the stepfather
which Mr. Bonner deemed sufficient. I am not placing any stress on
the boys power of selecting his own school or religion since he
is 17 years old and the law requires that he be 18. I want to
stick to the clear tenor of the law.

Dear Monsignor:

Just returned this evening at eleven P.M. after an all days trip to Carizzo to secure the signature of John Williams. He had promised it when he asked me to take the boy and kept his promise as soon as I told him what I came for. I have at least 15 witnesses to what was transacted then for the Indians were at the cowboy camp when I arrived and all were there. I have only two signatures as I thought that would suffice. I had to walk fourteen miles to get up to their place. I am about tired out now so I am going to cut this short. John has also penned a letter of his own dictation to the commissioner telling his own story and explaining how the boy came to go. As you can see from his own letter he was perfectly free. His asking to take the child to St. John's was spontaneous. Now since all is settled I hope that this is the end of the matter. It was not anything for the officials here to worry about anyhow if they only knew their regulations.

Dear Father Fidelis:

I have your letters of September 15 and 19, the latter inclosing a statement and a certificate signed by John Williams by thumb mark and witnessed by Charles Truax and Clinton Cody, expressing Williams' desire as stepfather and guardian of Marcus Gatewood that the boy go to St. John's Mission School at Komatke, Arizona.

I am keeping the statement. There is no need of presenting it to the Indian Office unless the case is called to the attention of the Office by Superintendent Donner. I do not think he will do so. I enclose the certificate. You should present it to the Superintendent. That will satisfy his agreement with you that the request in writing of the parent could be obtained later.

From your statement of the case I see nothing to criticise except that it was unfortunate that the fact could not be made known to Superintendent Donner and Principal Mackey that the boy would go to St. John's at the beginning of the new term. You and I must surely sympathize with the principal's desire to keep that number in the seventh grade, especially when the pupil has been in the school some time. In our mission schools we desire the same.

But the right of the parent or guardian to change schools outside of the school term is an unquestioned right.

Dear Father Fidelis:

Referring to the case of Marcus Gatewood, I hope that you consult with a priest of excellent judgment like Father Gerard Brenneke.

The right of the parent to send his children to the mission school is exactly as stated in my telegram of September 17, 1923 to Father Augustine, which you quote. But Superintendent Donner may claim that this is a case of changing religion and that it therefore falls under the decision reached in the agreement brought about by Father Novatus Benzing and Inspector Hammond. In that case the parent or guardian would simply have to appear before the Superintendent.

In order to carry out your agreement with Superintendent Donner, either you or John Williams will have to present or send the certificate. In this case you do it. In the spirit of the Benzing-Hammond agreement, I am inclined to think that a Superintendent could require the personal appearance of the parent or guardian even for a change of school, except where the contrary custom is well established and the inconveniences would be too great. I have in mind the fact that the Sisters at St. Catherine's, Santa Fe, go out about a week before the schools open and gather up the children. If they find a child whose parents really desire that the child shall now enter St. Catherine's, Commissioner Burke agreed with me that the child might be taken and the Superintendent notified at the earliest possible date. But the consent of the Superintendent is not asked.

On the other hand I have no doubt that you try to cooperate as fully as possible with the Superintendent and other employees.

Sub-section C of Section 130 of The General Regulations for Religious Worship and Instruction of Pupils in Government Indian Schools provides, "That transfers from one religious denomination to another of children under 18 years of age shall only be permitted upon voluntary request of the parent, or guardian, who shall appear before the reservation superintendent unaccompanied by priest or minister and signify in writing his desire as to the religious affiliations of his child." This rule arose as a result of the Benzing-Hammond agreement.

I am inclined to think that Superintendent Donner could require the personal appearance of the guardian. Marcus Gatewood is of Lutheran denomination. He has made this change to your mission school and will most likely change his religion.


